
IBOs Accreditation Process Overview

General process overview

As the energy market is a heavily regulated industry, it is vital that any person promoting the service is fully trained on the industry standards; therefore all IBOs have to register themselves, complete the training and pass the exam before they can start promoting the service to prospective customers.

Any IBO who promotes or acquires an energy customer without registration and completion of the test will be subject to compliance action including permanent suspension.








Training and exam compliance



The IBO has to enter their Online Shop/ MyACN web and click on the accreditation link. After that, the IBO needs to **create an account** to proceed with the accreditation process.








Contact details should be provided by the IBO. Once the process is completed, the IBO will be redirected to a confirmation screen and will receive a confirmation email. The IBO's status will remain 'Pending' until they pass the exam.







The IBO will receive an email with an activation link. Once the IBO creates an account, **the status changes to 'Pre-active'.**

Training and exam compliance



The IBO needs to log in to their accreditation website. In case the IBO cannot remember the password, they can reset it.

The IBO will be asked to provide the email address associated to the account and will receive an email with a link that will allow the generation of a new password. Once the process is completed, the IBO will receive a confirmation message and they will be able to log in.
