If the customer does not remain an ACN customer until the end of the initial contract period of 12-months, ACN will charge the normal activation fee of £ 33.95 incl. VAT upon termination. The currently listed price includes the £1.85 discount when Direct Debit is used. Without Direct Debit there will be an additional charge of £1.85 (incl. VAT) per month.

² Price per call up to 1 hour, including calls to 0845 & 0870 numbers (does not include indirect access numbers and dial-up internet access). After 1 hour local & national weekend calls are charged at 10.0p per minute, 0845 calls are 0.56p and 0870 calls are 1.10p per minute.

³ During the week 0845 calls are 2.04p peak & 0.56p off peak per minute whilst 0870 calls are 8.25p peak & 1.10p off peak per minute.

Optional Add-ons:

Select National - Get the first 250 minutes of all domestic landline calls included in your package and with no call set up fee for just £4.00 (incl. VAT) extra a month. After the minutes are used up each call will be charged as per the table above.

Select Mobile - Get the first 250 minutes of all domestic mobile calls included in your package and with no call set up fee for just £5.00 (incl. VAT) extra a month. After the minutes are used up each call will be charged as per the table above.

Select International Zone 1 - Get the first 100 minutes of calls to 61 international destinations included, both fixed and mobile with a call set up fee for just £5.00 (incl. VAT) extra a month. After the minutes are used up each call will be charged as per the prices on page 2.

Select International Zone 2 - Get the first 100 minutes of calls to 42 international destinations included, both fixed and mobile with a call set up fee for just £9.00 (incl. VAT) extra a month. After the minutes are used up each call will be charged as per the prices on page 2.

Select International Zone 3 - Get the first 100 minutes of calls to 40 international destinations included, both fixed and mobile with a call set up fee for just £13.00 (incl. VAT) extra a month. After the minutes are used up each call will be charged as per the prices on page 2.
